Joint German-Danish "Support to Agriculture and Rural Economic Development of Disadvantaged Mountainous Areas" (SARED)

CALL FOR APPLICATIONS No. 03/2016 SARED Grant Facility

The Ministry of Agriculture, Rural Development and Water Administration - MARDWA in cooperation with the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ) announce the Third **Call for Applications of the SARED Grant Scheme for investments in the agro-food sector** for 3 value chains: (i) small ruminants, (ii) fruit & nut trees, and medicinal and (iii) aromatic plants (MAPs).

The 3rd Call is open from March 14th, 2016 -- June 30th, 2016 at 16:30h

The SARED Grant Facility is co-financed by the German and Danish Governments with GIZ being the Contracting Authority. The implementation of the project is done in close collaboration with the Ministry of Agriculture, Rural Development and Water Administration – MARDWA.

The third Call is open for all citizens (individual farmers, physical and legal persons incl. ACA) who work and operate in the territory of the 6 selected regions of the Republic of Albania, namely Shkoder, Kukes, Diber, Elbasan, Berat and Korca, in production, collection, agro-processing and marketing of agriculture products within the 3 value chains of (i) small ruminants, (ii) fruits and nuts, and (iii) medicinal and aromatic plants (MAPs).

For the 3rd Call, applications will not be accepted from the region of Korca in relation to mechanisation on farm under VC 2 (fruits and nuts). Referring to the GfA, Annex 3 "List of eligible expenditures" excluded are the investment under point 2.1.02 "Purchase of technology/equipment/machinery which serve to the production and protection of the production in open field" and point 2.1.03 "Purchase of machinery and equipment which are proportional to the farm size for Fruits and Nuts"!

All applications must be submitted in two copies, only in person at the premises of Regional Directorates of Agriculture (RDA) in your respective regions during the normal working hours in an envelope indicating the name of the applicant and the VC for which the application is submitted and containing the application form, business plan as well as the accompanying documents as indicated in the Guideline for Applicants.

The principle of first come first serve will be applied for the opening and assessing the applications.

Total investment size per application (investment project) is: For on Farm investments:

-	Total eligible minimum investments size to be applied:	ALL	400,000
-	Total eligible maximum investments size to be applied:	ALL	3,500,000

For off Farm investment (collection/processing/marketing of agriculture products):

-	Total eligible minimum investments size to be applied:	ALL	700,000
-	Total eligible maximum investments size to be applied:	ALL	10,000,000

From the grant facility to the beneficiaries is granted in principle a financial support between 50% - 65% <u>of total eligible costs</u> and this is paid after the finalization by the beneficiaries of the investments for which the contract is signed.

For <u>on Farm investments</u> the grant size is between 65% - 75% of eligible costs as described in the GfA.

For <u>off Farm investments</u> the grant size is between 50% - 60% of eligible costs as described in the GfA.

For the 3rd Call for applications are applicable only the application templates (application form, business plan) and conditions of the Guideline for Applicants Version 3 which is published on website of MARDWA <u>www.bujgesia.gov.al</u>.

Applications can be submitted only for investments as described in the List of Eligible Investments (Annex 3 to the GfA) published on the website of MARDWA.

Note to potential applicants:

Applications sent by any other means or delivered to other addresses will be rejected.

Any application submitted or received after the deadline of the call will automatically be rejected.

Non-compliance with other major formal requirements as listed in the Guideline, are further reasons for automatic rejection.
